Mayor Smith invited members of the public to comment on the proposed budget .

Cindy Radcliffe-Mine is pretty much the same as what I said last, last two weeks ago. I'm disappointed in this budget. There's very little if anything

that impacts the daily lives of the people of this city. There's, the amount of money for the roads has gone down by 500 dollars, which probably is fair because you only spent 300 dollars on roads last year and you had 2,000 to spend. I mean, not counting A Street I realize that you got a grant for that 750 thousand dollars. What I'm talking about is the average roads in this town you spent very little if anything on roads. And I think that we have a lot of potholes, there are a lot of things that need to be fixed. Spend the money that's budgeted for it. The other thing is, the one thing that does kinda impact our lives that's in here and the only thing I can find that helps us is the Fourth of July that everybody seemed to enjoy last year that we're probably not even gonna do this year because it's too much money. Ya know, so, this is our money. It's a quarter of a million dollars and you didn't even have additional security lighting put in here. Ya know, the lighting that you have around town might be sufficient, but more lighting means, more light on criminals. Ya know, I can name a couple houses that I'd rather have spot lights on. But still, this money should be spent, the majority of it, on our behalf, not just for our attorneys and city planners and the staff. It should be spent on things that help our everyday lives. Those dumpsters, out of a quarter million dollars you guys can't find 2,000 dollars to have dumpsters come down? Not everybody has a truck. Not everybody can lift up...I know many people in this town that couldn't lift up a, a refrigerator or dishwasher to get it into a dumpster or into a truck to get it to the city dump. You are always harping, all of you, about cleaning up this city, well let's help 'em a little bit. Let's get them a little bit of money, and it's a small amount out of a quarter million dollars, so they can just bring it down or have help bringing it down and putting it in a dumpster. Ya know, let's give 'em a little bit more lighting you guys haven't done anything. I'm not even sure that you guys have really studied this and seen how much. And when it comes to raising salaries us that are on Social Security, we're getting what, 2.3 percent raise? You shouldn't be giving any more than that to anybody, if not nothing at all. Thank you Jill for, you know, saying that you wouldn't take one. But you know, the point is that, you should, the people that get Social Security that pay into those taxes, there's a lot of people in this town that make very little. You're raising taxes. You're raising sewer fees. The water's going up. A lot of people are within ten bucks of that. And now, you, you do nothing for them, that they can see every day. They can't even get a pothole fixed. So, I'm disappointed in this. I was hoping that maybe somebody, one of you, would have said, let's (unintelligible) a couple (unintelligible) somewhere, and possibly do something. But that's not gonna be, so election is 2019 people, let's see if we can find somebody that will help us.
