3. The Park Board requested Council consideration to update the Park rental fee schedule. The park board would like to see the parks used more by local residents and they feel the rental fee schedule is not in line with other local communities. The Council agreed with the Board's idea and the city staff was tasked with preparing the changes and presenting them back to Council for approval.
4. Council discussed options for the limb disposal site. Councilor Parsons provided a quote for getting the property next to the water treatment facility logged and said that the city would get about \$40,000 for the project. The City Clerk/Treasurer gave her opinion about the challenges that running a limb disposal site would bring for the city administration.

Public Comment:

Jill Nielson-Wanted to respond to the misinformation being posted on the internet about a party being thrown for Mayor Ken Smith. She clarified that the city was not paying for any part of the activity. All invited employees were attending on their own time, all food and the rental of City Hall was being paid for by private funds and that anyone is allowed to rent City Hall for \$5 and hold a private event. No city business would be discussed at the event. She stated that she could not afford to pay for lunch for everyone in the community and that was why the party was only for the invited guests.
